2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **Bright Moon Teacher's Training College, Shyam Bihar Colony, Khadi Bagh Road, Chomu, Jaipur (Raj.) - 303702** for conducting **B.Ed.** Course of one year duration with an annual intake of 100 (One Hundred Only) students under clause 7(12) of Regulation dated 13.01.2006 subject to fulfillment of the following:

- (I) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
- (II) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.



Course of Secondary (level) of one year duration with an annual additional intake of 100 (Hundred Only) (Existing 100 + Additional 100 = 200)** students from the academic session **2008-09** under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following:

- i) **The admission of students shall be only after affiliation by the examining body before the commencement of the academic year and the admission of students shall be completed well before the cut of date prescribed by the examining body for the academic year 2008-2009 failing which the recognition will be deemed to be for the next year academic year that is 2009-10.**
- ii) **Formal orders for recognition / permission will operate for 2008-2009 only if requirement of 180 teaching days in the session would be fulfilled as per calendar of the University / Affiliating body.**
- iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the **Northern Regional Committee.**
- iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

WHEREAS, in terms of section 14/15(1) of the NCTE Act, 1993, **Bright Moon Teacher Training College, Shyam Vihar Colony, Khadibagh Road, Chomu, Distt. Jaipur, Rajasthan** had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant recognition/permission for B.Ed. course on 21.11.2007. The recognition was granted by NRC vide its order No. F.NRC/NCTE/RJ-1424/2008/60696 dt. 04.09.2008 for conducting B.Ed. course of Secondary (Level) of one year duration with an annual additional intake of 100 (Hundred Only) (Existing 100+ Additional 100 = 200) students from the academic session 2008-09 and a revised order also issued to the institution by NRC vide its order no. AND WHEREAS, the matter was placed before the NRC in its 250th meeting (Part-1, 19-20.02.2016). The Committee decided that VT be constituted to verify the infrastructural and institutional facilities as also the teaching faculty in position in the new premises and also to verify the land and building documents as per the requirements of NCTE Regulations, 2014.

AND WHEREAS, the inspection of the institution was conducted under section 14 of the NCTE Act, 1993 on 26.04.2016 and the VTR received in the NRC office on 30.04.2016. The VTR was considered by the NRC in its 252nd (Part-11, 01.05.2016) meeting held from 19th April to 02nd May, 2016. The Committee decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC and following observation was made:-

The Committee decided to permit the shifting of the institution at 526/1, 527/2, 528/2, Kalu Ka Baas, Govindgarh, Chomu, Distt. Jaipur, Rajasthan for both the courses."
